- (b) All substitutes shall be governed by eligibility rule (a) above.
- (c) Each participant is responsible for determining his/her eligibility.
- (d) The eligibility of team members shall be certified to the host club by the president or secretary of the team's club with respect to rule (a) with confirmation that curling experience includes all years of curling.
